What are the UL standards for energy storage systems?

UL 1973: Batteries for Use in Stationary and Motive Auxiliary Power Applications. Safety standard for modules and battery systems used in stationary energy storage systems. UL 9540, Energy Storage Systems and Equipment. Safety standard for energy storage systems used with renewable energy sources such as solar and wind.

What are energy storage requirements?

1.1 These requirements cover an energy storage system(ESS) that is intended to receive and store energy in some form so that the ESS can provide electrical energy to loads or to the local/area electric power system (EPS) when needed. Electrochemical,chemical,mechanical,and thermal ESS are covered by this Standard.

Are energy storage codes & standards needed?
