Which crystalline silicon photovoltaic cells are excluded from the investigation?

Also excluded from the scope of the investigation are crystalline silicon photovoltaic cells, not exceeding 10,000 mm² in surface area, that are permanently integrated into a consumer good whose function is other than power generation and that consumes the electricity generated by the integrated crystalline silicon photovoltaic cell.

Are crystalline silicon photovoltaic cells a countervailable subsidy?

Enforcement and Compliance, International Trade Administration, Department of Commerce. The U.S. Department of Commerce (Commerce) preliminarily determines that countervailable subsidies are being provided to producers and exporters of crystalline silicon photovoltaic cells, whether or not assembled into modules (solar cells), from Thailand.

When will photovoltaic export rebates be eliminated in China?

China will eliminate value-added tax (VAT) export rebates for photovoltaic products from April 1, 2026, according to a joint notice released on Jan. 9 by the Ministry of Finance of the People's Republic of China and the State Taxation Administration.

Can CSPV cells be used in building-integrated PV?

In addition to standard size CSPV modules, CSPV cells can be used in building-integrated PV ("BIPV modules" or "BIPV products"). BIPV products are materials integrated into the building envelope, such as the facade or roof, containing CSPV cells.
